### 注意事项:

- 申请表提交:** 表格填写清晰、完整、正确后,请盖章签字,并将扫描件发 email 回复我们,我们在 3 个工作日内处理。FAPAS 提供的测试样品量应该是足够的;若需要额外样品,请在下述表格中打“**ü**”,需另行收取额外样品费用。但额外样品的分析结果,FAPAS 将不做评价;若需要评价报告,请申请该轮水平测试 2 次。
- 订单取消:** 如在报名截止日期前未收到您的款项,我们将取消您的定单。申请表递交后,申请人若需取消测试,则:以本计划测试样品派发时间为基准,提前一个月以上的,将保留 50%的测试费用作为信用额度,只能用于下次报名的费用抵扣;若是在 1 个月内取消报名,仍须全额支付测试费用。
- 测试样品签收:** 测试样品在普通邮寄(航空邮寄)方式下一般可在两周内到达,如果自样品发出日起 10 个工作日仍未收到样品,请于第十个工作日与我们联系;若未在此时限内联系我们,由此引起的损失将由申请人自行承担。测试样品轮次标记 F 的需要特快加急运送,以减少途中耽搁时间并及时抵达贵实验室,一般 4 个工作日内送达。fapas 会在样品发出后及时发送 email 通知,请根据 fapas 提供的运单号及时跟踪和查收。有些样品包装中会含有冰块。即使样品到达时没有保持冰冻,因已经保持足够长的冰冻时间,样品仍可正常使用。如果您对某些测试样品有加急需求,请及时联系我们来尽快安排。以上两种样品运送方式中,FAPAS 均不对样品在海关造成的损失或损毁负责。
